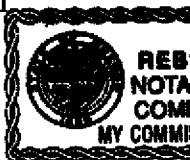

THIS INDENTURE, Made this 4/19/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and CALIBER HOME LOANS, INC., FKA VERICREST FINANCIAL, INC., hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1403897CV, Klamath County Sheriff's Office Number J15-0074, in which CALIBER HOME LOANS, INC., FKA VERICREST FINANCIAL, INC., ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and SAM R. ELAM; DONNA R. ELAM; CARTER-JONES COLLECTION SERVICE, INC.; STATE OF OREGON; AND OCCUPANTS OF THE PREMISES was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 5/13/2015, directing the sale of that real property, pursuant to which, on 8/19/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$51,987.00, to CALIBER HOME LOANS, INC., FKA VERICREST FINANCIAL, INC., who was the highest and best bidder, that sum being the highest and best sum bid therefore. TO HAVE AND TO HOLD the same unto the grantee and grantee's heirs, successors, and assigns forever.

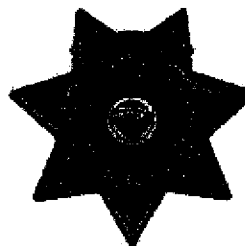
