# ASSIGNMENT AND ASSUMPTION OF OPTION AGREEMENT

THIS ASSIGNMENT AND ASSUMPTION OF OPTION AGREEMENT ("Assignment"), is dated as of the  $\frac{1}{2}$  of  $\frac{1}{2}$  of  $\frac{1}{2}$ , 2016 (the "Effective Date"), by and between Jason Nash ("Assignor"), and Joshua William Bloom and Amanda Marie Bloom (collectively, "Assignee").

#### **RECITALS**

- A. Assignor, as "Owner," and Hecate Energy Bonanza, LLC ("Hecate") are parties to that certain Amended and Restated Option Agreement dated as of November 9, 2015 (the "Option Agreement") providing Hecate with the option to purchase the real property described in Exhibit A attached hereto ("Property"). A Memorandum of Option Agreement was recorded on November 25, 2015 as Document No. 2015-012851 with the County Clerk of Klamath County, Oregon to provide notice of the existence of the Option Agreement. Capitalized terms used in this Assignment without definition shall have the meaning ascribed to such terms in the Option Agreement.
- B. The Option Agreement amends and restates in its entirety a prior Option Agreement dated as of November 4, 2013 ("<u>Prior Agreement</u>") with respect to the Property. A Memorandum of Option Agreement providing notice of the existence of the Prior Agreement was recorded on April 3, 2014 as Document No. 2014-002868 with the County Clerk of Klamath County, Oregon.
- C. Assignor desires to assign to Assignee all of Assignor's right, title and interest in, to and under the Option Agreement, and Assignee is willing to accept such assignment and assume all of the rights, duties and obligations of Assignor under the Option Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. <u>Assignment of Purchase Agreement</u>. Effective as of the Effective Date, Assignor hereby sells, transfers, assigns and conveys to Assignee, its successors and assigns, all of Assignor's right, title and interest in, to and under the Option Agreement, including, without


limitation, the right to receive Option Payments payable after the Effective Date and all other rights, duties and obligations of Owner thereunder with respect to such interests.

- 2. <u>Assumption of Obligations</u>. Effective as of the Effective Date, Assignee hereby assumes and agrees to perform all of the rights, duties and obligations of Assignor under the Option Agreement.
- 3. Representations of Assignee. In order to induce Hecate to consent to the conveyance of the Property to Assignee, Assignee hereby represents and warrants to Assignor and Hecate that neither Assignee nor any entity controlling, controlled by, or under common control with Assignee is engaged in the development, generation, transmission or sale of energy in any form.
- 4. <u>Governing Law.</u> This Assignment shall be governed by and interpreted in accordance with the laws of the State of Oregon, without regard to conflict of laws principles.
- 5. <u>Binding Effect</u>. This Assignment and the provisions contained herein shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.
- 6. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
- 7. <u>Miscellaneous</u>. This Assignment: (i) may not be canceled, modified or amended except by written instrument executed by all parties hereto, including Hecate; and (ii) contains the entire agreement between the parties hereto. If any term or provision of this Assignment shall, to any extent, be determined to be invalid or unenforceable, the remainder of this Assignment shall not be affected and each term or provision of this Assignment shall be valid and enforceable to the fullest extent permitted by law.
