KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

Everett O. Stevens, Joyce B. Stevens, Michael G. Voight and Debra D. Voight, not as tenants in common but with rights of survivorship,

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to wit:

**The Easterly 97 feet of Lot 5 in Block 4 of FIRST ADDITION TO PINE GROVE PONDEROSA,
according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.**

The true and actual consideration paid for this transfer, stated in terms of dollars, is **\$180,000.00**.
However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
