NOTICE OF EASEMENT ANNULMENT

THIS NOTICE OF EASEMENT ANNULMENT (the "Notice") is executed this 27th day of May, 2016, by Green Diamond Resource Company, a Washington corporation, having a mailing address of 1301 Fifth Avenue, Suite 2700, Seattle, Washington 98101 ("Green Diamond").

RECITALS:

- A. Green Diamond is successor to Klamath Lumber Co. as Grantor under the Deer Spring Grant of Easement and Right of Way and the Holbrook Grant of Easement and Right of way (collectively, the "Easement and Right of Way"). Each Easement and Right of Way is defined below.
- B. The Deer Spring Grant of Easement and Right of way between Klamath Lumber Co. and the United States of America, Department of Interior, Bureau of Land Management ("BLM") was dated April 10, 1968 and recorded in the real property records of Klamath County, Oregon at Vol. M68 Page 3077 and covered property in the County of Klamath, State of Oregon, NW ¼ SW ¼ Section 20, T 40 S, R 15 E, Willamette Meridian.
- C. The Holbrook Grant of Easement and Right of way between Klamath Lumber Co. and BLM was dated March 5, 1968 and recorded in the real property records of Klamath County, Oregon at Vol. 68 Page 2000 covered property in the County of Klamath, State of Oregon, SE ¼ SW ¼ Section 31, T 40 S, R 15 E, Willamette Meridian.
- D. Both the Deer Spring Grant of Easement and Right of way and the Holbrook Grant of Easement and Right of way provide that "grantor may at any time ... upon giving the grantee 6 months written notice and upon payment to the grantee of the present reasonable value of the improvements, annul in full or in part the easement rights and privileges granted herein."

- E. On or about August 17, 2015, Green Diamond provided BLM written notice of annulment of the Deer Spring Grant of Easement and Right of way and the Holbrook Grant of Easement and Right of way.
- F. In a letter dated January 27, 2016, the BLM confirmed to Green Diamond that the "present reasonable value of the improvements" associated with the Deer Spring Grant of Easement and Right of way and the Holbrook Grant of Easement and Right of way was \$1,300.00, each.
- G. On or about May 9, 2016, Green Diamond paid to BLM consideration in the amount of \$2,600.00.
- H. BLM confirmed receipt of payment of \$2,600.00 and the resultant annulment of each Easement and Right of Way via that certain letter from BLM dated May 18, 2016, reference Nos. 2920/4100 (ORL040) (the "Annulment") and attached hereto as **Exhibit A** to this Notice.
- I. Green Diamond desires to execute this Notice, which is to be recorded in the real property records of Klamath County, Oregon, in order that third parties may have notice of the Annulment.

NOTICE:

NOW THEREFORE, in accordance with the covenants in each Easement and Right of Way, Green Diamond executes and provides notice that the Deer Spring Grant of Easement and Right of way and the Holbrook Grant of Easement and Right of way are permanently null and void and are of no force and effect whatsoever.

IN WITNESS WHEREOF, Green Diamond caused this Notice to be executed by their respective duly authorized representatives as of the date first above written.

Dear Mr. Schuler:

This letter is in regards to the annulment of the Grant of Easement for both Deer and Holbrook Springs (OR56909, OR56916). On August 18, 2015, Green Diamond Resource Company (GRDC) provided the Bureau of Land Management (BLM) notice that they would be annulling the Deer and Holbrook Springs Easements and requested the BLM determine the "present reasonable value of the improvements." The BLM determined that the present value to replace each spring with new stock tanks and piping was \$1,300 per spring. This figure was agreed upon by both parties during phone calls and subsequent email correspondence last year.

The BLM and the grazing permittee for the Bear Valley allotment use rights terminated on May 9, 2016 upon receipt of the agreed upon present and reasonable value of the spring improvements (\$ 2,600). A copy of the receipt for payment is enclosed.

BLM will note our files in regards to the annulment of Grant of Easement for both Deer and Holbrook Springs, OROR 56916 and OROR 56909. The BLM has no obligation in regards to recording the annulment of these easements with the county. No other forms or documents will be signed by the BLM.
