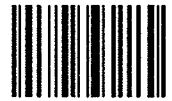

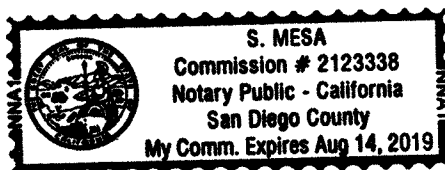

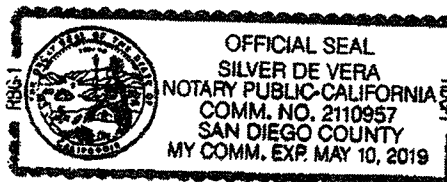

## NOTICE TO RESIDENTIAL TENANTS
