# NOTICE OF TERMINATION OF GEOTHERMAL LEASE AND AGREEMENT

This NOTICE OF TERMINATION OF GEOTHERMAL LEASE AND AGREEMENT (this "Notice") is effective as of June 22, 2016 of the GEOTHERMAL LEASE AND AGREEMENT ("Geothermal Lease") entered into by and between (i) Pete Nevin and Melinda Nevin, husband and wife (collectively and individually, "Owner"), having an address at 17017 Highway 140E, Dairy, OR 97625, (ii) Woodline Solar, LLC, a Delaware limited liability company, ("Tenant"), having an address at 2003 Western Avenue, Suite 225, Seattle, WA 98121, Attention: Bill Eddie, (iii) Jeri Coppa-Knudson, chapter 7 trustee for the estate of In re Klamath Basin Geopower, Inc. case no. 15-51578 ("Previous Tenant") and (iv) Optim, Inc., an affiliate of Klamath Basin Geothermal, Inc. ("Original Tenant"), having an address at 200 South Virginia Street, Suite 560, Reno, NV 89501, Attention: Bill Honjas.

WHEREAS, the Original Tenant and Owner entered into a Geothermal Lease and Agreement as of October 22, 2010 ("Geothermal Lease") for the development of a geothermal energy project located near the town of Dairy in Klamath County, Oregon on lands ("Real Property") described in Exhibit A.

WHEREAS, Previous Tenant was a trustee authorized and ordered by United States Bankruptcy Court, District of Nevada to assign and transfer the Geothermal Lease, between Original Tenant and Owner;

WHEREAS, the Tenant terminated all rights granted in the Geothermal Lease pursuant to paragraph seven of the Geothermal Lease by delivering a release and surrender notice ("Owner Notice") to Owner dated June 22, 2016.

**NOW THEREFORE,** Tenant provides this Notice to all persons that the Geothermal Lease is terminated in its entirety.
