A portion of Block "D", FISHER'S ADDITION TO BAKER CITY, according to the official plat thereof, including a tract adjoining said Block "D" on the East, in the Southwest quarter of the Northwest quarter of Section 16, Township 9 South, Range 40 East of the Willamette Meridian, in Baker City, County of Baker and State of Oregon, more particularly described as follows:

BEGINNING at a point on the West line of said Block "D", said point being North 133.0 feet from the Southwest corner of said Block "D"; thence North 89°57' East 220.0 feet; thence North 50 feet; thence North 89°57' East 6.0 feet to a point on the West bank of the Powder River; thence along the West bank of the Powder River the following courses and distances: North 10°28' West 60.51 feet; North 02°33' East 112.54 feet; and North 04°54' East to a point of intersection with the Easterly extension of the North line of Lots 13 and 44, Block "D"; thence South 89°57' West 28.69 feet along the Easterly extension of the North line of Lots 13 and 44, Block "D", to the Northeast corner of said Lot 44; thence South 8.0 feet; thence South 89°57' West 200.0 feet to a point on the West line of said Lot 13, said point being South 8.0 feet from the Northwest corner of said Lot 13; thence South 315.32 feet along the Westerly line of said Block "D" to the POINT OF BEGINNING.
