BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That

Walter Douglas,

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

Walter Douglas, Michael M. Douglas, and Terry Lynn Douglas, not as tenants in common but with rights of survivorship,

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

Lots 25 and 26 in Block 7 of Stewart Addition, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

EXCEPTING THEREFROM:

Beginning at the Southeast corner of Lot 25, Block 7, STEWART ADDITION, thence North 50 feet on the East line of Lot 25, thence Westerly to a point on the West line of Lot 26, which point is 70 feet North of the Southwest corner of Lot 26; thence South 70 feet to the Southwest corner of Lot 26; thence East to the place of beginning.

The true and actual consideration paid for this transfer, stated in terms of dollars, is **\$30,000.00.**


However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.


