THIS INDENTURE, Made this 7/27/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Clinton D. Gardner, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1404002CV, Klamath County Sheriff's Office Number J15-0134, in which WELLS FARGO FINANCIAL OREGON, INC., ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and UNKNOWN HEIRS OF HAZEL V. TONEY; UNKNOWN SUCCESSOR TRUSTEES OF THE HAZEL V. TONEY REVOCABLE LIVING TRUST; UNKNOWN BENEFICIARIES OF THE HAZEL V. AND MORE COMMONLY KNOWN AS 4836 BARNEY COURT, KLAMATH FALLS, OREGON 97601.

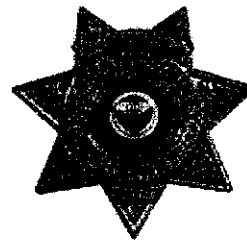
