The Southwesterly 28 feet of Lot 30 and all of Lot 31, except the Southwesterly 20 feet thereof in the WEST PARK ADDITION, to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon

The true and actual consideration paid for this transfer, stated in terms of dollars, is as stipulated in Decree of Dissolution of Marriage and Property Settlement Agreement, Case No. 16DR10341.

However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.
