Parcel 1 of Land Partition 20-10 being a replat of Parcel 2 of "Major Land Partition 50-91", along with the NW 1/4 NE 1/4 of Section 17, situated in Section 17, 20, W 1/4 of Section 21, and E 1/2 of Section 18, Township 38 South, Range 11 E.W.M., Klamath County, Oregon Hungry Hollow Youth Ranch April, 2011
