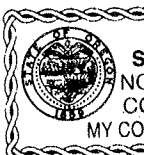

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1404497CV, Klamath County Sheriff's Office Number J15-0119, in which DEUTSCHE BANK TRUST COMPANY AMERICAS AS INDENTURE TRUSTEE FOR THE REGISTERED HOLDERS OF SAXON ASSET SECURITIES TRUST 2004-1 MORTGAGE LOAN ASSET BACKED NOTES AND CERTIFICATES, SERIES 2004-1 was plaintiff(s) and ESTATE OF CRAIG E RICARDS, DECEASED; UNKNOWN HEIRS AND DEVISEES OF CRAIG E. 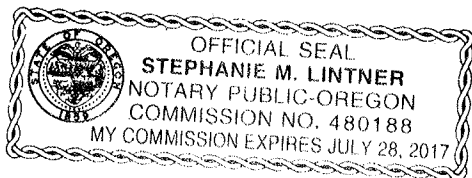


