
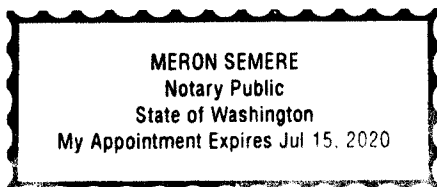



NOTICE TO RESIDENTIAL TENANTS



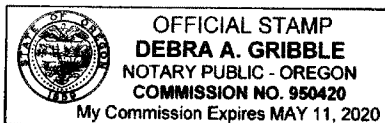
