THIS INDENTURE, Made this 08/28/2016, by and between Frank Skrah, Sheriff of Klamath County,
Oregon, hereinafter called the grantor, and Planet Home Lending, LLC, hereinafter called the grantee;
WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1202826CV, Klamath County Sheriff's Office Number J15-0133, in which GREEN PLANET, LLC., ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS, was plaintiff(s) and TERESA L. YUNKER; WAYNE G. 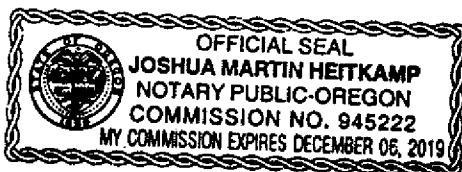

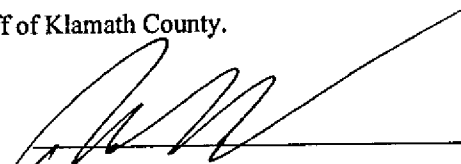
