THIS INDENTURE, Made this 08/28/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association (FNMA), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1401245CV, Klamath County Sheriff's Office Number J15-0099, in which GREEN TREE SERVICING LLC, was plaintiff(s) and BARBARA A. SIMONSON; RANDALL D. 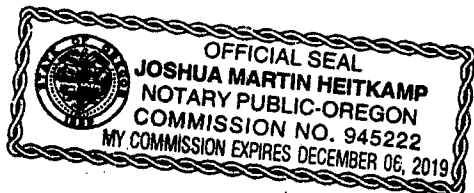
