**Quitclaim Deed  
(ORS 93.865(1))**

Funeral Service Agency, Inc., an Oregon corporation, doing business as National Funeral Trust Service (**NFTS**), releases and quitclaims to Huntly LP, a Nevada limited partnership authorized to do business in Oregon (**Huntly**), the real property described below (**Parcel 8**).

Parcel 8 – TWP 39 Range 10, Block Sec 18, Tract por NW 4NW4, Acres 5.00

Huntly and three other entities purported to convey Parcel 8 and three other parcels of real property to *Eternal Hills Memorial Gardens Endowment Care Trust c/o National Funeral Trust Service (Eternal Hills)* by Bargain and Sale Deeds recorded in the Klamath County, Oregon Real Property Records on July 12, 2016, Reception Numbers 2016-007349 (**Huntly Deed**), 2016-007351 (**Gordon Trust Deed**), 2016-007352 (**Bydand Deed**) and 2016-007353 (**Klamath Tribute Deed**).

Articles of Incorporation for Eternal Hills, as a domestic nonprofit corporation, were filed with the Oregon Secretary of State Corporation Division (**Corporation Division**) on August 10, 2016, Registry Number 1240230-94. The Corporation Division determined that the Eternal Hills Articles of Incorporation could not be filed. Thus, no such entity exists. It is purported that Eternal Hills is somehow related to NFTS by use of the NFTS name, address and telephone number. It is not.

NFTS has no interest and claims no interest in Eternal Hills. NFTS takes the position that Huntly's purported transfer of Parcel 8 to Eternal Hills, an entity that does not exist, has no effect.

In any event, NFTS does not accept the Huntly Deed and NFTS does not accept and does not claim any interest in Parcel 8.


