THIS INDENTURE, Made this 6/21/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Flagstar Bank, N.A., hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1403695CV, Klamath County Sheriff's Office Number J15-0063, in which FLAGSTAR BANK, FSB was plaintiff(s) and DIANE J GASCON; CARTER JONES; COLLECTION SERVICE, INC.; AND PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE PROPERTY DESCRIBED IN THE COMPLAINT HEREIN was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 4/6/2015, directing the sale of that real property, pursuant to which, on 10/28/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$35,280.00, to Flagstar Bank, FSB, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 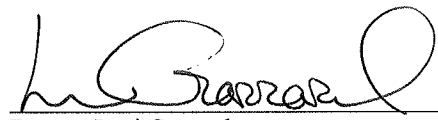

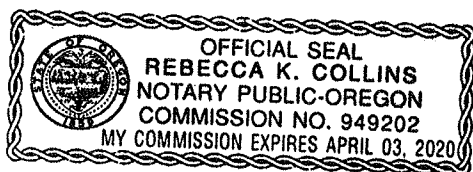
