MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated September 12, 2016, is made and executed between Malcolm S. Meyers and Marlene Meyers Trustees of the Meyers Family Living Trust dated December 4, 1998, whose address is 5524 Grace Dr, Klamath Falls, OR 97601 ("Grantor") and Banner Bank, whose address is Medford Crater Lake Branch, 3369 Crater Lake Hwy, Medford, OR 97504-9259 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated June 2, 2006 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

Parcel 2 of Land Partition 18-02 being Lot 5, Block 6 of Tract No 1149 "La Wanda Hills No. 2", situated in the Southwest 1/4 of Section 14, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

Maturity Date is hereby extended to September 12, 2041.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
