Lots 3, 11, 12, 13 and 14 Block 3, SIXTH STREET ADDITION to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon. TOGETHER WITH that portion of vacated alley which inured thereto.

ALSO TOGETHER WITH that portion of vacated Key Street.
