STATUTORY WARRANTY DEED

Beginning at the Northwest corner of Lot 1, Block 1, TRACT 1172-SHIELD CREST; thence along the North line of said Lot 1 South 88°49'47" East 38.48 feet; thence leaving said North line South 01°10'13" West 150 feet to the North line of Parcel 1 of Land Partition 60-92; thence along said North line and the North line of Parcel 2 of said Land Partition North 88°49'47" West 105.18 feet to the Northwest corner of said Parcel 2; thence North 25°08'41" East 164.18 feet to the point of beginning.
