LIMITED POWER OF ATTORNEY

3. To endorse any checks or other instruments received by Ocwen and made payable to Trustee.
4. To do any other act or complete any other document that arises in the normal course of servicing.

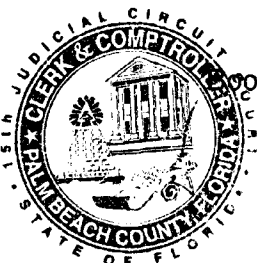
