- C. Jason and Angela Cox are the purchasers, from Jack Wood of a tract of land described as 2508-00800-00700-000 (Exhibit A)
- D. There is a well on the Wood Tract 2508-00900-01700-00 (Exhibit B)

Agreements:

- 1. Well Easement: Wood hereby grants to Cox a perpetual, nonexclusive easement to access and use the existing well located on the Wood Tract and draw water there for the use and benefit of the Cox Tract. In granting this easement, Wood reserves the right to himself, his heirs and assigns, forever the right of access to the use of the well.
