WHEREAS, Michael Fronckowiak, applicant, requested approval of an amendment to the Comprehensive Plan designation from General Commercial to Urban Residential and associated zone change from General Commercial (CG) to Medium Density Residential (RM) on approximately 0.42 acres; and

WHEREAS, the subject property is described as Tax Lot 2200 in Section 2BC of Township 39 South, Range 9 East Willamette Meridian; and

WHEREAS, the Klamath County Planning Department provided proper notice of a public hearing held on November 22, 2016 before the Klamath County Planning Commission and Board of County Commissioners; and

WHEREAS, the applicant submitted said request for the Comprehensive Plan amendment and associated zone change in due form for consideration; and

WHEREAS, based on testimony entered and consideration of the whole record, and making the proposed findings of fact in the application submittal and Staff Report their own, the Klamath County Planning Commission concluded the application was in conformance with State Law, Klamath County Land Development Code and Comprehensive Plan, and forwarded a recommendation of Approval for Planning File CLUP/ZC 9-16 to the Board of County Commissioners; and

WHEREAS, based on testimony entered and after consideration of the whole record; and, with a recommendation from the Klamath County Planning Commission, the Klamath County Board of Commissioners acting within their authority, accepted the Planning Commission's recommendation, and APPROVED the request of Planning File CLUP/ZC 9-16.
