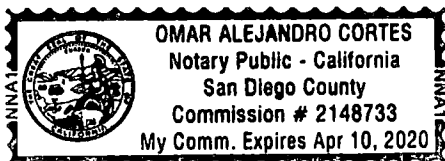

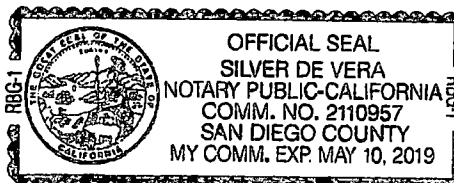

## NOTICE TO RESIDENTIAL TENANTS

## NOTICE TO RESIDENTIAL TENANTS
