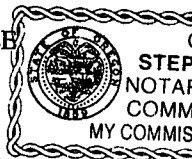

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV22063, Klamath County Sheriff's Office Number J16-0019, in which U.S. BANK TRUST, N.A., AS TRUSTEE FOR LSF8 MASTER PARTICIPATION TRUST was plaintiff(s) and MICHAEL L. BLACKBURN, INDIVIDUALLY AND AS CONSTRUCTIVE TRUSTEE OF THE ESTATE OF DARLENE D. BLACKBURN; UNKNOWN HEIRS OF DARLENE D.
