THIS INDENTURE, Made this 12/08/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Nationstar Mortgage LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1500801CV, Klamath County Sheriff's Office Number J16-0032, in which NATIONSTAR MORTGAGE LLC was plaintiff(s) and JASON BOATRIGHT; COURTNEY BOATRIGHT; CARTER JONES COLLECTION SERVICES; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 345 COOK STREET, KLAMATH FALLS, OR 97601 was defendant(s), in which a Writ of Execution, which was issued on 02/12/2016, directing the sale of that real property, pursuant to which, on 05/27/2016 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$94,000.00, to Nationstar Mortgage LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

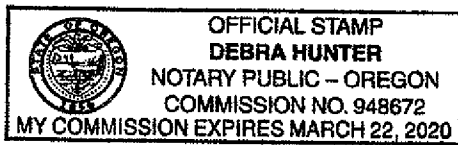
