If Klamath County determines that any maintenance, repair or replacement is required on the Cattle Under Crossing system and this work is not performed by the Owner, Klamath County shall make written request for the work to be performed. If the work is not completed within thirty (30) days after receipt of the written notice, Klamath County shall perform the maintenance, repair and/or replacement and take whatever steps deemed necessary for the Cattle Under Crossing system to be kept in a safe and functional state with all costs to be paid by the Owner. Klamath County shall provide the owner with written verification of all cost incurred and the Owner shall pay the amount within fifteen (15) days after receipt.

No alterations or changes are to be made to the Cattle Under Crossing system without approval in writing by Klamath County.

The Owner agrees to hold Klamath County harmless from any and all claims for personal injury, death or injury to property associated with this agreement.
