THIS INDENTURE, Made this 12/09/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, c/o Ditech Financial, LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1402478CV, Klamath County Sheriff's Office Number J16-0024, in which GREEN TREE SERVICING LLC was plaintiff(s) and THE ESTATE OF LUCEAL M. ROSS, DECEASED; BRIAN ROSS; GREG ROSS; JIM ROSS; UNKNOWN HEIRS AND DEVISEES OF LUCEAL M. 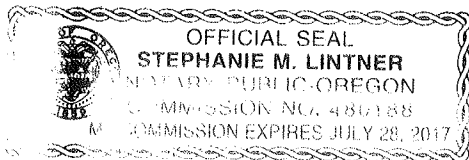
