THIS INDENTURE, Made this 12/23/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Nationstar Mortgage LLC, d/b/a Champion Mortgage Company, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1403621CV, Klamath County Sheriff's Office Number J15-0117, in which NATIONSTAR MORTGAGE, LLC D/B/A CHAMPION MORTGAGE COMPANY was plaintiff(s) and THE ESTATE OF ORSON E. BRANDON; THE UNKNOWN HEIRS AND ASSIGNS OF ORSON E. BRANDON; THE UNKNOWN DEVISEES OF ORSON E. 

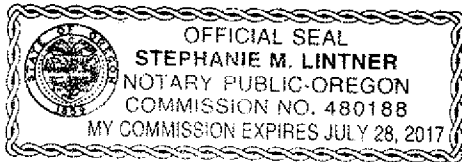
