The true and actual consideration paid for this transfer, stated in terms of dollars, is \$(0) Spousal transfer.


However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

In construing this deed, where the context so requires, the singular includes the plural and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.


