KNOW ALL MEN BY THESE PRESENTS, that I, Delores M. Baldwin, have made, constituted and appointed, and by these presents do hereby make, constitute and appoint **Charles G. My attorney and all persons unto whom these presents shall come may assume that this power of attorney has not been revoked until given actual notice either of such revocation or of my death.

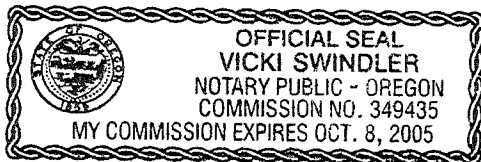
