Sessom Trust's undivided one-half interest as a Beneficiary of the Trust Deed dated November 5, 2005, made by Lloyd Curtis Sorg, Manager, and William Curtis Sorg, Member, of Triple Sorg Investments, LLC, an Oregon Limited Liability Company, as Grantors, in favor of AmeriTitle, as Trustee, for the benefit of Ernest R.
