Lot 10, Block 12, FIRST ADDITION TO KLAMATH FALLS, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon. TOGETHER WITH 1/2 vacated Fifth Street adjoining Lot 10.
