Grantor(s), hereby convey and warrant to

Richard William Avey and Daretta Kay Avey, as Tenants by the Entirety,

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

Parcel 1:

A parcel of land situated in Block 8 of Supplemental Plat of Linkville, now City of Klamath Falls, Oregon, more particularly described as follows:

Beginning at the most Southerly corner of Lot 4 in said Block; thence N. 39° 04' 50" E. along the Northwesterly line of Pine Street a distance of 102.83 feet to a cross chiseled in the sidewalk; thence no 51° 03' 32" W. a distance of 120.0 feet to the Northwesterly line of Lot 3 in said Block 8; thence S., 39° 02' 39" W. along the Northwesterly line of Lots 3 and 4, said Block 8 a distance of 102.56 feet, more or less, the Northeasterly line of Fourth Street thence S. 50° 55' W. along said Northeasterly line and the Westerly line of Lot 4 a distances of 120.0 feet, more or less, to the point of beginning.
