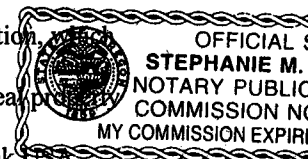

THIS INDENTURE, Made this 03/17/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and HSBC Bank USA, N.A., hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300944CV, Klamath County Sheriff's Office Number J16-0013, in which HSBC BANK USA, N.A. was plaintiff(s) and MICHAEL C. ERLER; SHIRLEY W. ERLER; WELLS FARGO BANK, N.A.; KLAMATH FALLS FOREST ESTATES HOMEOWNERS' ASSOCIATION, INC.; DISCOVER BANK, OTHER PERSONS OR PARTIES, INCLUDING OCCUPANTS, UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE PROPERTY DESCRIBED IN THE COMPLAINT HEREIN was defendant(s), in which a Writ of Execution, was issued on 01/15/2016, directing the sale of that real property, pursuant to which, on 03/16/2016 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$97,086.00, to HSBC Bank USA, N.A., who was the highest and best bidder, that sum being the highest and best sum bid therefore. 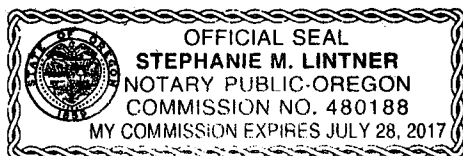
