

LEGAL DESCRIPTION

Beginning at a point on the East line of Homedale Road, which point is South 650.65 feet and East 30 feet from the Northwest corner of the NE1/4 SE1/4 of Section 14, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon and continuing thence South along said East line of Homedale Road a distance of 228.65 feet to a point; thence North 89° 42' East a distance of 187.8 feet to a point; thence North 228.38 feet to a point; thence South 89° 42' West a distance of 187.8 feet to the point of beginning in the S1/2 NE1/4 SE1/4 of Section 14, Township 39 South, Range 9 East of the Willamette Meridian Klamath County, Oregon.
