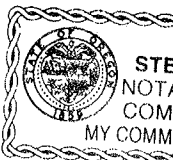

THIS INDENTURE, Made this 03/22/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV26028, Klamath County Sheriff's Office Number J16-0050, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION was plaintiff(s) and LEROY JACKSON, JR.; SHARON M.
