THIS INDENTURE, Made this 02/16/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Dominick Robertson, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1500024CV, Klamath County Sheriff's Office Number J16-0034, in which Dominick Robertson was plaintiff(s) and Alexander Herbert was defendant(s), in which a Writ of Execution, which was issued on 02/18/2016, directing the sale of that real property, pursuant to which, on 04/29/2016 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$45,063.55, to Dominick Robertson, who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. 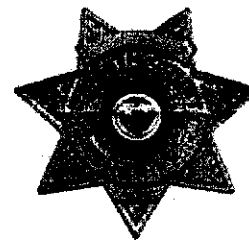

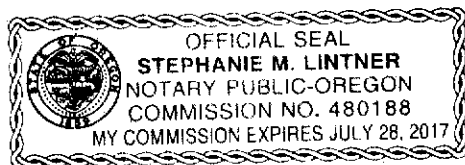
