

THIS INDENTURE, Made this 03/20/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, c/o Bayview Loan Servicing, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV26791, Klamath County Sheriff's Office Number J16-0061, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FNMA") was plaintiff(s) and MARIA FE M. SIKES; RICHARD G. SIKES; AND PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE PROPERTY DESCRIBED IN THE COMPLAINT HEREIN, was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 04/12/2016, directing the sale of that real property, pursuant to which, on 09/09/2016 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$231,200.00, to FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FNMA"),, who was the highest and best bidder, that sum being the highest and best sum bid therefore.
