THIS INDENTURE, Made this 03/20/2017, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and NRZ REO VI CORP, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1500786CV, Klamath County Sheriff's Office Number J16-0051, in which CITIBANK, N.A., NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE OF NRZ PASS-THROUGH TRUST VI was plaintiff(s) and THOMAS C. WISENER AKA TOM C. WISENER; HEATHER M. WISENER; BANK OF AMERICA, N.A.; OREGON AFFORDABLE HOUSING ASSISTANCE COOPERATION; WELLS FARGO BANK, N.A.; AND PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE PROPERTY DESCRIBED IN THE COMPLAINT HEREIN was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 03/23/2016, directing the sale of that real property, pursuant to which, on 08/24/2016 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$79,000.00, to CITIBANK, N.A., NOT IN ITS INDIVIDUAL CAPACITY, BUT SOLELY AS TRUSTEE OF NRZ PASS-THROUGH TRUST VI, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 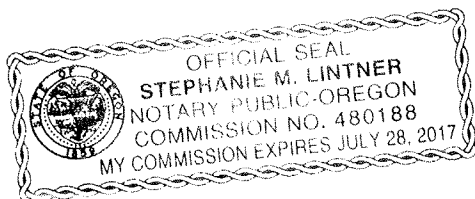
