Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A parcel of land situated in the SW1/4 of Section 14, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the West line of said SW1/4 of Section 14, which bears North 28° 07' 05" West a distance of 1,500.00 feet and North 46° 08' 22" East a distance of 950.0 feet from the Section corner common to Sections 14, 15, 22 and 23, said Township and Range; thence South 60° 26' 26" East a distance of 1,310.41 feet to a point on the North line of the S1/2 SW1/4 of Section 14; thence North 89° 17' 08" East along said North line a distance of 850.0 feet to a point which is 660 feet West of the Northeast corner of said S1/2 SW1/4; thence South 01° 44' 37" East, parallel with the East line of the W1/2 of Section 14, a distance of 1,319.58 feet to the South line of Section 14; thence South 89° 14' 34" West along said line a distance of 521.26 feet to a point; thence North 0° 48' 40" West a distance of 411.75 feet to a point; thence North 46° 36' 44" West a distance of 2070.0 feet, more or less, to a point on the West line of said Section 14; thence North along said West line to the point of beginning.
