## STATUTORY WARRANTY DEED

Grantor(s), hereby convey and warrant to

## Christine J. Thomas,

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A portion of Block 24, ELDORADO HEIGHTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, described as follows:

Beginning at the most Westerly corner of said Block 24; thence South 49 degrees 50' East along the Southwesterly boundary of said Block 24, a distance of 55.0 feet to the beginning of a curve, the radius of which is 756.78 feet, which curve forms a portion of the Southwest boundary of said Block 24; thence Southeasterly along the arc of the curve of said Southwest boundary, a distance of 293.9 feet, to the true point of beginning; thence continuing along the arc of the curve of said Southwest boundary, 71.7 feet; thence North 67 degrees 14' East along the extended radius of said curve, 103.23 feet, more or less, to the East boundary of said Block 24; thence North 0 degrees 18' East, along said East boundary, 56.37 feet, more or less, to the Southwest corner of Lot 17 of said Block 24; thence South 64 degrees 26' West, 16.16 feet, to the Southwest corner of said Lot 17, which point is 110.0 feet from the Southwesterly boundary of said Block 24, a distance of 29.84 feet to the most Easterly corner of the property described in deed recorded in Book 277 at page 102 of Klamath County Deed Records; thence South 61 degrees 48' West along the extended radius of said curve, 110.0 feet; more or less, to the true point of beginning, which last described line is the Southeasterly line of the property described in said Deed recorded in said Volume 277 at page 102, Klamath County Deed Records.
