**FINAL ORDER
OF FORFEITURE**


WHEREAS, on September 2, 2015, the Court entered a Preliminary Order of Forfeiture in accordance with FED. R. CRIM. P. 32.2(b), forfeiting any and all interest in the property (real, personal or otherwise) described in Paragraph 134 of the Second Superseding Indictment to the United States subject to the provisions of 18 U.S.C. §981, 982; 21 U.S.C. § 853 and 28 U.S.C. § 2461;

WHEREAS, notice and publication of the forfeiture action has been made, and the time for filing petitions for said property has expired. Petitioners Evin Hoover and David Lee Boice filed Petitions with the Court claiming a property interest in some of the assets described in Paragraph 134 of the Second Superseding Indictment;

WHEREAS, Plaintiff United States of America and Petitioners Evin Hoover and David Lee Boice, after conducting an ancillary forfeiture proceeding, stipulated to recognize the property interest of the Petitioners on some of the assets described in Paragraph 134 of the Second Superseding Indictment, agreeing to return the assets mentioned in the parties' Stipulations (Docs. 348 and 358). Therefore,

1 IT IS HEREBY ORDERED pursuant to 18 U.S.C. §981, 982; 21 U.S.C. § 853 and 28
2 U.S.C. § 2461 and FED. R. CRIM. P. 32.2(c)(2), that the Court's September 2, 2015,
3 Preliminary Order of Forfeiture is final and all right, title, claim, and interest of any and
4 all persons or entities in and to any and all interest in the property (real, personal or
5 otherwise) described in Paragraph 134 of the Second Superseding Indictment, is forfeited
6 to the United States, except for the property that will be returned to Petitioners Evin
7 Hoover and David Lee Boice under the Stipulations filed with the Court (Docs. 348 and
8 358).


