The true and actual consideration for this conveyance is **\$146,000.00**.

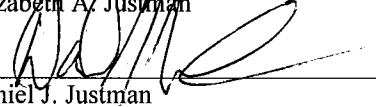

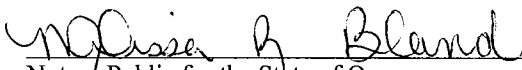
