WHEREAS, the Klamath County Board of Commissioners voted to approve the Planning Commission recommendation to amend the Comprehensive Plan Map and Zoning Map; and

NOW, THEREFORE, the Klamath County Board of Commissioners ordains that the amendments to the Klamath County Comprehensive Plan and Zoning Map as proposed in File No. CLUP/ZC 4-17, which are attached hereto and marked as Exhibit "A," and incorporated herein by reference are hereby adopted with the following condition of approval.

1. Prior to the Final Order and Ordinance for this action being signed by the Board of Commissioners, the applicant shall obtain the necessary access permit from

the Oregon Dept. of Transportation (ODOT) for a commercial use on the subject property and provide a copy to the Planning Dept.



FINAL ORDER

WHEREAS, Donnie Frye, applicant, requested approval of an amendment to the Comprehensive Plan designation from Rural to Agriculture and change the zoning designation from R-5 (Rural Residential – 5 acre minimum lot size) to EFU-CG (Exclusive Farm Use – Crops and Grazing) on 13.93 acres; and

WHEREAS, the subject property is described as Tax Lots 100 and 300 in Section 34BD and Tax Lots 401 and 402 in Section 34 of Township 40 South, Range 8 East Willamette Meridian; and

WHEREAS, the Klamath County Planning Department provided proper notice of a public hearing held on May 23, 2017 before the Klamath County Planning Commission and Board of County Commissioners; and

WHEREAS, the applicant submitted said request for the Comprehensive Plan amendment and associated zone change in due form for consideration; and

WHEREAS, based on testimony entered and consideration of the whole record, and making the proposed findings of fact in the application submittal and Staff Report their own, the Klamath County Planning Commission concluded the application was in conformance with State Law, Klamath County Land Development Code and Comprehensive Plan, and forwarded a recommendation of Approval for Planning File CLUP/ZC 4-17, with the Condition of Approval, to the Board of County Commissioners; and

WHEREAS, based on testimony entered and after consideration of the whole record; and, with a recommendation from the Klamath County Planning Commission, the Klamath County Board of Commissioners acting within their authority, accepted the Planning Commission's recommendation, and unanimously APPROVED the request of Planning File CLUP/ZC 4-17 with the following Condition of Approval.

1. Prior to the Final Order and Ordinance for this action being signed by the Board of Commissioners, the applicant shall obtain the necessary access permit from the Oregon Dept. of Transportation (ODOT) for a commercial use on the subject property and provide a copy to the Planning Dept.
