### PERSONAL REPRESENTATIVE'S DEED

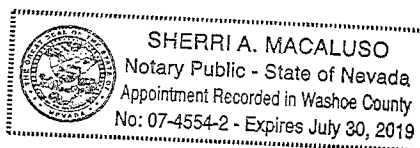
