

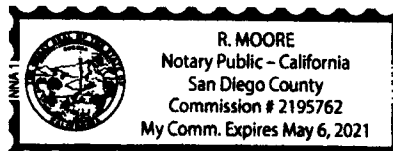

NOTICE TO RESIDENTIAL TENANTS
