THIS INDENTURE Made this 16 day of June 2018, by and between

Theresa Foeller the duly appointed, qualified and acting personal representative of the estate of Dora Annette Dodd deceased, hereinafter called the first party, and

Phillip Doddridge,

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The following described real property in Klamath County, Oregon:

All that portion of Tract No. 5 in Block 4, ALTAMONT ACRES, that lies North of the ditch that was constructed for drainage purposes and which ditch runs approximately East and West through the center of said tract, as shown by the official plat of record now on file in the office of the County Clerk of Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$20,000.00 However, the actual consideration consists of or includes other property or value given or promised which is part / whole of the consideration.
