BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That **Gregory L. Huck**, who acquired title as **Greg L. Huck**,

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto **Gregory L. Huck**,

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

The Westerly 201 feet of Lot 1 and the Westerly 201 feet of the Northerly 16.2 feet of Lot 2 in Block 4 of SECOND ADDITION TO ALTAMONT ACRES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

EXCEPTING THEREFROM that portion conveyed to Klamath County for road purposes by instrument recorded July 1, 1965 in Volume 362, page 563, Deed Records of Klamath County, Oregon.

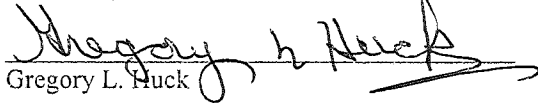
The true and actual consideration paid for this transfer, stated in terms of dollars, is 0.00.

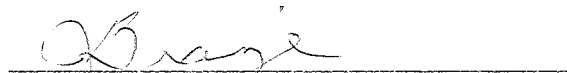
