CORPORATE ASSIGNMENT OF DEED OF TRUST

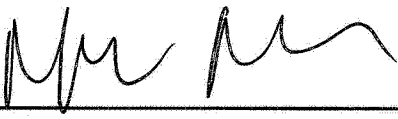

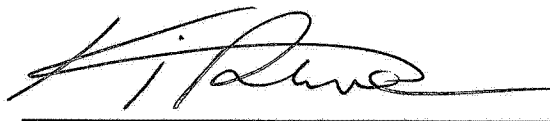
